19. **Training**

The Supplier is required to train the designated Purchaser's technical and end user personnel to enable them to effectively operate the total equipment.

20. **Installation & Demonstration**

The supplier is required to do the installation and demonstration of the equipment within one month of the arrival of materials at the INST site of installation, otherwise the penalty clause will be the same as per the supply of materials.

21. **Warranty:** Minimum One Year Warranty shall have to be provided by the firm. The Warranty should be comprehensive on site.

22. **AMC:** Annual Maintenance Contract (AMC)/Comprehensive Maintenance Contract (CMC) up to next five years after warranty period is over should be quoted separately.

Institute of Nano Science and technology invites tender from reputed art firms/ sculpture artist for the following items:

- (i) A sculpture, complementing fence and uplighting of the proposed sculpture at the central vista in front of INST main building (refer Annexure 1 for details)
- (ii) Wall Mural at the reception hall of INST main building (refer Annexure 2 for details)
- (iii) Foundation wall stone at the reception hall of INST main building (refer Annexure 3 for details)

The minimum qualification form (Annexure 4) along with supporting documents should be submitted in a single envelope. The financial bid must be submitted in a separate envelope.

The installation of the sculpture, complementing fencing, uplighting of sculpture, wall mural, lighting of wall mural, and foundation stone will be the sole responsibility of the art firm/sculpture artist.

**A. Minimum qualifying criterion:**

The bidding art firm/sculpture artist must satisfy the following criterion:

- (i) Execution of sculpture and/or wall mural work in government institutes/ government departments.
- (ii) Prior experience of executing sculpture/wall mural work of more than Rs. 20 lakhs.
- (iii) Must have own art gallery
- (iv) Prior experience of building SS/MS sculpture larger than 20 feet height.
- (v) Prior experience of creating theme based wall mural of larger than 150 Sq feet

**B. Technical qualification:**

Art firm/sculpture artist having minimum qualifying criterion will have to present the following within five days of receipt of an email invitation for the same:

- (i). A 3D- maquette (at least 18 inch tall) of the proposed sculpture and model design of wall mural.
- (ii) A detailed technical presentation on the proposed sculpture, complementing fence, up-lighting and the wall mural.

Based on B(i) and B(ii) a technical qualification will be made.

**C. Final allotment of work order**

Financial bid of art firm/ sculpture artist who will technically qualify (based on 1 and 2) will be further processed for final allotment of the order.


### **Annexure 1: Sculpture**

**Basic Elements:** The sculpture must incorporate the following three celebrated elements from the fields of material physics, biology and chemistry:

(i) **Graphene** : The sculpture must have Graphene as one of the element that will symbolize the component of material physics in nanoscience. Graphene is a material that has revolutionized the field of nanomaterials with innumerable possibilities of applications and discovering novel scientific discoveries. The discovery of this graphene has been recognized by way of Nobel Prize in physics in the year of 2002.

(ii) **DNA double helix** : The sculpture must have DNA helix as one of the element that will symbolize the component of biology in nanoscience. DNA is a fundamental molecule in all known organisms that carries genetic information. The discovery of double helix structure of DNA has led to umpteen discoveries and understanding in the development, functioning of organisms and viruses.

(iii) **Molecular Motor** : The sculpture must have a 2<sup>nd</sup> generation synthetic molecular motor molecule (image below) as one of the element that will symbolize the component of chemistry in nanoscience. The discovery of synthetic molecular motor has brought a revolutionary concept in nanotechnology that envisages to transform applications across fields. The synthesis of artificial molecular motors was recognized by the way of Nobel Prize in chemistry in the year of 2016.



The section comprising molecular motor molecule should have a movable part to demonstrate a perspective of motion for the rotor segment of the motor molecule.

**Modification:** The three elements mentioned above may be modified for the aesthetics without losing the scientific relevance of the components.

**Material and specification:** (i) The sculpture should be fully made of high quality SS 304 stainless steel.

(ii) Surface of the sculpture should be coated with high gloss transparent PU coating for protection from weather condition and dust.

(iii) The height of the sculpture should be of minimum 18 feet but not larger 20 feet.

**Certification:** The sculpture should be certified by structural engineer to ensure its strength and stability. The certificate for this must be submitted by the art firm/sculpture artist.

**Designer Fencing:** An appropriate complementing designer fencing made of MS (with silver coating) should be provided around the sculpture for its protection. The fencing should be circular with 13 m diameter.

**Uplighting:** Appropriate and sufficient uplighting must be provided around the sculpture. The uplighting should be able to appropriately and sufficiently highlight the sculpture.

### **Annexure 2: Wall mural**

(i) The wall mural should be 3dimensional and made of MS (powder coated), FRP (ISO) and acrylic (atleast 5mm thickness) as per the requirement of the subject.

(ii) The wall mural size should be 17 feet x 8 feet.

(iii) The wall mural should be thematic based on nanoscience and technology.

(iv) The wall mural should be artistic and purpose oriented as well.

(v) The wall mural should have structures and concepts based on nanomaterials and sciences.

(vii) Appropriate lighting arrangement for highlighting the dimension and depth of various elements of the wall mural should be provided.

### **Annexure 3: Foundation stone**

(i) A wall mounted foundation stone of 6 feet by 4 feet made of sand stone with natural texture should be provided

(ii) The letters of the inaugural message should be engraved on the stone.
